

**Greater Wellington Regional Council Movin'March Art Challenge**  
**Terms and Conditions**  
**Updated 28.3.19**

1. The Movin'March Art Challenge (**Competition**) is run by Greater Wellington Regional Council of 15 Walter Street, Te Aro, Wellington 6011 (**GWRC**). The Competition will be governed by these Terms and Conditions and by entering this competition you (**you, your** or the **Entrant**) are deemed to have accepted these Terms and Conditions.
2. The Competition is open to any child attending a school in the Wellington region that is registered on the Movin'March website [www.movinmarch.com](http://www.movinmarch.com), with the exception of immediate family members of the GWRC Sustainable Transport team.
3. If you are younger than 18 years of age, you must have the consent of your parent or legal guardian to enter the Competition.

**Competition Period**

4. The Competition will commence at 12:01am on 1 March 2019 and end at 11:59pm on 29 March 2019 (**Competition Period**).

**Entry**

5. To enter the Competition, each Entrant must:
  - (a) either colour, or colour and free-draw on the colouring-in sheet designed by Ali Teo for Movin'March 2019 (which can be downloaded from the Movin'March website);
  - (b) provide the Entrant's name, age, class and school details on or attached to the colouring-in sheet;
  - (c) submit the completed colouring-in sheet to the Entrant's school and be chosen as the one representative design for that school for one of the three age categories. The age categories are 5-7, 8-10 and 11-12 years; and
  - (d) have their colouring-in sheet received by the school's local council's Movin'March contact by Thursday 18 April 2019,during the Competition Period (each, an **Entry**).
6. You may only submit one Entry during the Competition Period and each Entrant can win only one prize.
7. You are responsible for ensuring that any information provided as part of an Entry is complete and correct. Incomplete, incorrect, indecipherable, illegible or late entries will be invalid.
8. GWRC reserves the right, at any time, to verify the validity of Entries and Entrants (including an Entrant's identity, age, school and place of residence) and to disqualify any Entrant who submits an Entry that is not in accordance with these Terms and Conditions or who tampers with the entry

process. Failure by GWRC to enforce any of its rights at any stage does not constitute a waiver of those rights.

## **Draw**

9. Within 24 business days of the end of the Competition Period, GWRC Road Safety Co-ordinators who are judging entries will choose one winner for each of the three age categories in each of the six Wellington districts from all of the valid entries received during the Competition Period. This will result in a maximum of eighteen district winners (**District Winning Entries**). The Movin' March Co-ordinator(s) will then judge these District Winning Entries and select a winning Entry for each age category for the region, giving a total of three regional winners (**Regional Winning Entries**).
10. GWRC will use its best endeavours to contact each winner (both the District Winning Entries and the Regional Winning Entries) by phone, email or through the winner's school (using the contact details supplied in each Winning Entry) within 5 business days from the prize draw. However, if GWRC cannot contact any winner within a reasonable time, GWRC may redraw for the relevant prize.
11. Where any winner is younger than 18 years of age, GWRC may award the prize to the winner's parent or legal guardian. GWRC may require the winner's parent or guardian to sign acceptance of these Terms and Conditions prior to claiming a prize.
12. The winners may be announced on the GWRC Movin' March Facebook page on or about the 17<sup>th</sup> May 2019.
13. All decisions regarding this Competition by GWRC will be final and no correspondence will be entered into.

## **Prize(s)**

14. The prizes for the Competition will be:
  - (a) for each of the District Winning Entries (i.e. three age category winners from each local council), a small prize to be determined by GWRC and valued at up to \$30 each; and
  - (b) for each of the Regional Winning Entries (i.e. three age category winners for the Wellington region), a \$100 Prezy Card for each age category winner. Prezy Cards may be redeemed at participating retailers and the specific terms and conditions for the Prezy Card can be found on the website: [www.prezycard.co.nz/terms-conditions/](http://www.prezycard.co.nz/terms-conditions/). (The Regional Winning Entries are awarded the major prize only, and are not entitled to receive the small prize that is awarded to the District Winning Entries.)
15. The prizes will be sent to the winners' schools for awarding. The prizes cannot be transferred, exchanged or redeemed for cash.
16. GWRC will use its best endeavours to provide the prizes set out in these Terms and Conditions. If any of the prizes are unavailable for whatever reason, GWRC reserves the right to substitute the prize for a prize of an equivalent value.

17. By entering the Competition, you agree to GWRC using your personal information supplied to contact you if you are a prize winner. If you are a prize winner, you agree to participate in publicity organised by GWRC and you also agree to the use of your name, likeness and image for publicity and promotional purposes for an unlimited period in any media, without compensation. This includes, but is not limited to, social media and event websites and media releases.

#### **General**

18. An Entry and any copyright subsisting in an Entry irrevocably becomes, at the time of Entry, the property of GWRC. GWRC may use, promote and distribute the winning colouring and/or drawing designs and otherwise use them for the purposes of this Competition and ongoing Movin'March promotions.
19. Subject to any applicable laws which cannot be excluded, GWRC, its employees and agents will not be liable for any loss, damage or injury of any nature incurred or suffered by any person (including but not limited to indirect or consequential loss or loss arising from negligence) arising directly or indirectly out of or in connection with this Competition or with winning, redeeming or benefiting from the prize.
20. You understand that you are providing your information to GWRC and the information you provide will be collected, stored and used only for the purpose of this Competition and as otherwise set out in (and in accordance with) GWRC's Privacy Statement (<http://gw.govt.nz/privacy-statement/>).
21. GWRC, in its sole discretion, reserves the right to cancel, suspend, terminate or modify the Competition if fraud, technical failures or any other factor beyond GWRC's reasonable control adversely affects GWRC's ability to conduct the Competition as contemplated in these terms and conditions, subject to any written directions from any regulatory authority. Any such termination or modification will be notified on the Movin'March website.
22. These terms and conditions shall be governed by the laws of New Zealand and each Entrant agrees to submit to the non-exclusive jurisdiction of the courts of New Zealand.
