

**Greater Wellington Regional Council Movin'March WOW Family Day
Terms and Conditions**

1. The Movin'March WOW Family Competition (**Competition**) is run by Greater Wellington Regional Council of 15 Walter Street, Te Aro, Wellington 6011 (**GWRC**). The Competition will be governed by these Terms and Conditions and by entering the Competition, you (**you, your or Entrant**) are deemed to have accepted these Terms and Conditions.
2. The Competition is open to any school in the Wellington region that is registered on the Movin'March website www.movinmarch.com.
3. The Competition will be governed by these Terms and Conditions and entry into this Competition is deemed to be acceptance of these Terms and Conditions.

Competition Period

4. The Competition will commence at 12:01am 1 November 2018 and end at 11:59pm on 18 March 2019 (**Competition Period**).

Entry

5. To enter the Competition, an authorised representative from a qualifying school must email GWRC at schooltravel@gw.govt.nz and:
 - (a) set out what their school is planning for WOW Family Day during Movin'March 2019; and
 - (b) provide the contact details for their school, including an email and postal address,during the Competition Period (each email being an **Entry**).
6. Each school may submit only one Entry during the Competition Period and each school can win only one prize.
7. You are responsible for ensuring that any information provided as part of an Entry is complete and correct. Incomplete, incorrect, indecipherable, illegible or late entries will be invalid.

GWRC reserves the right, at any time, to verify the validity of Entries and Entrants and to disqualify any Entrant who submits an Entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by GWRC to enforce any of its rights at any stage does not constitute a waiver of those rights.

9. Within 10 business days of the end of the Competition Period, GWRC will randomly select one Entry from all the valid Entries received during the Competition Period (the **Winning Entry**).
10. GWRC will use its best endeavours to contact the winner by using the contact details supplied in the Winning Entry within 2 business days from the prize draw. However, if GWRC cannot contact any winner within a reasonable time, GWRC may redraw for the relevant prize.

11. The winner may be announced on the GWRC Movin'March Facebook page on or around 5 April 2019.
12. All decisions regarding this Competition by GWRC will be final and no correspondence will be entered into.
